Nov. 12-13: Public Officials to Speak on Risks to Cybersecurity, Financial Systems, Climate, and Social Insurance Programs at the American Academy of Actuaries 2015 Annual Meeting and Public Policy Forum

WASHINGTON – On Thursday, Nov. 12, and Friday, Nov. 13, the American Academy of Actuaries will hold its <u>2015 Annual Meeting and Public Policy Forum</u> in Washington, D.C. This event will mark the Academy's 50th anniversary of service to the public and the U.S. actuarial profession.
